7	WHEREAS, the Planning Commission of the City of Rialto, at its meeting of October
8	16, 2024, approved Tentative Tract Map 20685 subject to conditions; and
9	WHEREAS, ADC Rialto BFR, LLC (hereinafter the "Subdivider"), has filed Tract Map
10	20685 with the City Council of the City of Rialto, (hereinafter the "City"), in accordance with
11	Section 66456 of the California Government Code; and
12	WHEREAS, not all public improvements have been completed by the Subdivider as of
13	the filing of Tract Map 20685, and the Subdivider has requested that the City enter into a
14	Subdivision Improvement Agreement with the Subdivider to secure the cost of public
15	improvement in accordance with Section 66462 of the California Government Code.
16	
17	NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY
18	FIND, DETERMINE, AND RESOLVE AS FOLLOWS:
19	Section 1: Tract Map 20685 is in substantial conformance with the approved
20	Tentative Tract Map 20685.
21	Section 2: Requisite conditions associated with Tract Map 20685 have been satisfied
22	or supported with the necessary bonds for construction improvements.
23	Section 3: Tract Map 20685 is in conformance with the General Plan and Single
24	Family Residential (R-1C) Zone.
25	Section 4: Tract Map 20685 conforms to all applicable requirements of the
26	Subdivision Map Act of the State of California.

<u>Section 5:</u> In accordance with Section 66477.1 of the California Government Code, the offers of dedication to the public on Tract Map 20685 shall be accepted by the City Clerk, subject to improvement, who shall certify acceptance by signature on the map thereof.

<u>Section 6:</u> The City Council hereby approves a Subdivision Improvement Agreement for Tract Map 20685 with the Subdivider, ADC Rialto BFR, LLC, and accepts subdivision improvement securities in conformance with the requirements therein for public improvements. The City Manager is hereby authorized to execute the Subdivision Improvement Agreement on behalf of the City.

<u>Section 7:</u> The City Clerk shall cause to have recorded with the San Bernardino County Recorder the Subdivision Improvement Agreement.

**Section 8:** Tract Map 20685 is hereby approved for the purposes therein defined.
