18	'Proceeds of Taxes" shall be \$367,061,519 and actual appropriations from 'Proceeds of Taxes"		
19	submitted in Fiscal Year 2025-2026 for the City of Rialto shall be \$130,914,823 based on attached		
20	calculations; and		
21	Section 2: That the City of Rialto reserves the right to recalculate said limitation at a future		
22	time.
