11	service and transfers, without the consent of the City Manager; and
12	WHEREAS, the City Manager may transfer appropriations, between departments and within
13	their respective funds, as long as those appropriations do not exceed their fund total unless approved by
14	Council.
15	NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
16	HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:
17	Section 1: Authorize an increase in estimated revenues in Citizens' Option for Public Safety
18	Fund (COPS), Account No. 214-400-6994-7547 in the amount of \$160,556; and
19	Section 2: Approve an appropriation in the in Citizens' Option for Public Safety Fund
20	(COPS):
21	Account No. 214-500-6994-2021 in the amount of \$60,556; and
22	Account No. 214-500-6994-3030 in the amount of \$100,000,
23	for the purchase of technology, communication, equipment, and services for the City of Rialto Police
24	Department.
