**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
RIALTO, CALIFORNIA, AMENDING ITS 2022-2023 FISCAL  
BUDGET AND ACCEPTING ALLOCATION OF 2022/2023  
CITIZENS' OPTION FOR PUBLIC SAFETY (COPS) FUNDING**

**WHEREAS**, the budget for fiscal year 2022-2023 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

**WHEREAS**, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

**WHEREAS**, the City Manager may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES  
HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

**Section 1:** Authorize an increase in estimated revenues in Citizens' Option for Public Safety Fund (COPS), Account No. 214-400-6994-7547 in the amount of \$160,556; and

**Section 2:** Approve an appropriation in the in Citizens' Option for Public Safety Fund (COPS):

Account No. 214-500-6994-2021 in the amount of \$60,556; and

Account No. 214-500-6994-3030 in the amount of \$100,000,

for the purchase of technology, communication, equipment, and services for the City of Rialto Police Department.
