NOTICE IS HEREBY GIVEN that the City of Rialto has prepared its draft Consolidated Annual Performance Evaluation Report (CAPER) for Fiscal Year (FY) 2024-2025 for Community Development Block Grant (CDBG) and Investment Partnerships Program (HOME) funds. The publication of this notice notes the beginning of the 15-day public review period required under Federal Regulations 24 CFR 91.105. The public review and written comment period begins September 8, 2025, and runs through September 22, 2025.

Background: The CAPER provides an assessment of the City's performance in meeting Fiscal Year 2024-2025 housing and community development goals as outlined in the adopted Fiscal Year 2024-2025 One-Year Action Plan. Additionally, the CAPER discusses changes the City anticipates making in the upcoming year as a result of the assessment of Fiscal Year 2024-2025 annual performance.
