### **Summary Confirming Absence of Timely Written Objections (AB 2257)**

In connection with the proposed water and wastewater rate adjustments subject to a Proposition 218 public hearing scheduled for January 13, 2026, the City implemented the written objection procedures authorized under Government Code sections 53759.1 and 53759.2 (AB 2257). A Notice of Public Hearing mailed on November 6, 2025, established December 22, 2025, at 4:00 p.m. as the deadline for submission of written objections asserting that the proposed rates failed to comply with applicable legal requirements.

As of the December 22, 2025, deadline, the City had received the attached seven (7) letters that may have been intended to be written objections. However, because those letters did not specify any substantive grounds for alleging that the proposed water or sewer/wastewater rates do not comply with the requirements of Proposition 218, those letters do not meet the legal requirements of a "written objection" as defined by AB 2257.

Accordingly, because no written objections were submitted pursuant to AB 2257, no written responses were required or prepared, and this Attachment is included solely to document that fact as part of the administrative record for the January 13, 2026 rate-setting proceedings.
