PUBLIC HEARINGS

Chair Story stated the next item on the agenda is Conditional Development Permit No. 25-0001 (File PC-25-0807).

Senior Planner Sandra Robles made the presentation.

Conditional Development Permit No. 25-0001: A request to allow the operation of a massage parlor within an existing 900 square-foot commercial tenant space located at 2012 North Riverside Avenue, Suite F (APN: 0264-371-01-P-007) within the Neighborhood Commercial (C-1) zone. The project is categorically exempt pursuant to CEQA Section 15301 (Existing Facilities).

Ms. Robles advised that staff requested the item be continued to the next Planning Commission meeting.

Conditional Development Permit No. 25-0004: A request to allow the installation of electronic message board signage on an existing dental office building located at 1817 North Riverside Avenue within the C-1 (Neighborhood Commercial) zone. This project is categorically exempt pursuant to Section 15301 (Existing Facilities) of the California Environmental Quality Act (CEQA).

Commissioner Thompson asked whether the message board would display fixed or moving imagery. Mr. Rosas stated that it would display a variety of images related to the dental office. Commissioner Corral asked if advertising for other businesses would be included. Mr. Rosas confirmed that the content would be limited to the dental office only.

The applicant, Bob Hunt, provided a brief description of the project.

Chair Story opened the Public Hearing.

Commissioner Estvander made a motion to close the Public Hearing, seconded by Commissioner Thompson.

Chair Story closed the Public Hearing.
