1. PROBLEM STATEMENT

Describe the city, county, or jurisdiction this grant will impact.

The city of Rialto was founded in 1911. In 1950 Rialto was a small community that consisted of only 3,000 residents. The city population and economic activity have grown exponentially in recent years due to the influx in large residential developments and major distribution centers in the region.

As of the 2020 Census, Rialto had a population of 104,114 residents. With the addition of two large residential developments River Ranch and Lennar-Renaissance spanning over 1,500 acres, the city's growth is accelerating. By 2025, Rialto's population is projected to reach approximately 125,000 residents. Rialto continues to thrive, now ranking as the 67th most populous city in California out of 481 cities, a significant jump from its 70th position the previous year. Within San Bernardino County, Rialto is the 6th largest city among 24 cities. Spanning approximately 28 square miles, the city boasts an estimated daily population of over 200,000. This figure includes the thousands of individuals who visit, shop, and work in Rialto each day, reflecting its role as a growing hub of activity and opportunity.

Describe the problem(s) to be addressed, supported by current and relevant crash data. (most recent calendar year data/stats).

In February 2022, the department advanced its commitment to modernization by implementing Crossroads electronic citations (e-citations). This system allows officers to upload citations securely to the court system at the end of each shift, significantly reducing processing times and eliminating the inefficiencies inherent in manual workflows. The transition has improved accuracy, reduced administrative errors, and provided valuable data to support traffic engineering and enforcement strategies.

Since adoption, the Traffic Bureau has issued approximately 14,000 e-citations, eliminating manual entry that previously consumed 5–8 minutes per citation, saving more than 1,800 staff hours. This reclaimed time enables Records personnel to concentrate on higher-priority tasks, further improving overall departmental productivity. Building on this success, the department plans to equip all officers with portable printers to enable on-the-spot printing of citations and reports, further streamlining operations and enhancing community service. These innovations will allow the department to rapidly identify problem areas, allocate resources strategically, and maintain a strong focus on improving traffic safety throughout the city.

Define the target population the grant intends to serve and how they are affected by the problem(s).

The target population for the TRIP grant serves a dual purpose: enhancing operational efficiency within the Police Department's Records Bureau and improving accessibility and convenience for the community. Historically, the department relied on traditional paper citations, which required manual entry into the Records Management System (RMS). These citations were then physically delivered to the appropriate court for processing, creating delays that hindered citizens' ability to resolve their citations promptly. Furthermore, the paper-based system limited the department's ability to generate timely, accurate analytical data critical for identifying traffic safety trends and deploying enforcement resources effectively.

2. PERFORMANCE MEASURES

A. Goals:

1. Reduce the number of persons killed in traffic crashes.
2. Reduce the number of persons injured in traffic crashes.
3. To improve the timeliness, accuracy, completeness, uniformity, accessibility, and integration of the California Traffic Records System.

B. Objectives:

1. Purchase and implement a new electronic crash reporting solution or upgrade an existing electronic crash reporting system to allow for submission of complete crash reports to the California Highway Patrol's Statewide Integrated Traffic

3. The Recipient will insert the clauses of appendix A and E of this Assurance (also referred to as DOT order 1050.2A) ^[1] in every contract or agreement subject to the Acts and the Regulations.
4. The Recipient will insert the clauses of appendix B of DOT Order 1050.2A, as a covenant running with the land, in any deed from the United States effecting or recording a transfer of real property, structures, use, or improvements thereon or interest therein to a Recipient.

This ASSURANCE is binding on the State highway safety agency, other recipients, sub-recipients, sub-grantees, contractors, subcontractors and their subcontractors', transferees, successors in interest, and any other participants in the Highway Safety Grant Program. Submission of this certification is a prerequisite for making or entering into this transaction imposed by section 1352, title 31, U.S. Code. Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.

RESTRICTION ON STATE LOBBYING

GENERAL REQUIREMENTS

No employee, officer, or agent of a State or its subrecipient who is authorized in an official capacity to negotiate, make, accept, or approve, or to take part in negotiating, making, accepting, or approving any subaward, including contracts or subcontracts, in connection with this grant shall have, directly or indirectly, any financial or personal interest in any such subaward. Such a financial or personal interest would arise when the employee, officer, or agent, any member of his or her immediate family, his or her partner, or an organization which employs or is about to employ any of the parties indicated herein, has a financial or personal interest in or a tangible personal benefit from an entity considered for a subaward. Based on this policy:

1. The recipient shall maintain a written code or standards of conduct that provide for disciplinary actions to be applied for violations of such standards by officers, employees, or agents.
 - a. The code or standards shall provide that the recipient's officers, employees, or agents may neither solicit nor accept gratuities, favors, or anything of monetary value from present or potential subawardees, including contractors or parties to subcontracts.
 - b. The code or standards shall establish penalties, sanctions, or other disciplinary actions for violations, as permitted by State or local law or regulations.
2. The recipient shall maintain responsibility to enforce the requirements of the written code or standards of conduct.

DISCLOSURE REQUIREMENTS

No State or its subrecipient, including its officers, employees, or agents, shall perform or continue to perform under a grant or cooperative agreement, whose objectivity may be impaired because of any related past, present, or currently planned interest, financial or otherwise, in organizations regulated by NHTSA or in organizations whose interests may be substantially affected by NHTSA activities. Based on this policy:

1. The recipient shall disclose any conflict of interest identified as soon as reasonably possible, making an immediate and full disclosure in writing to NHTSA. The disclosure shall include a description of the action which the recipient has taken or proposes to take to avoid or mitigate such conflict.
2. NHTSA will review the disclosure and may require additional relevant information from the recipient. If a conflict of interest is found to exist, NHTSA may (a) terminate the award, or (b) determine that it is otherwise in the best interest of NHTSA to continue the award and include appropriate provisions to mitigate or avoid such conflict.
3. Conflicts of interest that require disclosure include all past, present, or currently planned organizational, financial, contractual, or other interest(s) with an organization regulated by NHTSA or with an organization whose interests may be substantially affected by NHTSA activities, and which are related to this award. The interest(s) that require disclosure include those of any recipient, affiliate, proposed consultant, proposed subcontractor, and key personnel of any of the above. Past interest shall be limited to within one year of the date of award. Key personnel shall include any person owning more than a 20 percent interest in a recipient, and the officers, employees or agents of a recipient who are responsible for making a decision or taking an action under an award where the decision or action can have an economic or other impact on the interests of a regulated or affected organization.

PROHIBITION ON USING GRANT FUNDS TO CHECK FOR HELMET USAGE **(applies to subrecipients as well as States)**

The State and each subrecipient will not use 23 U.S.C. Chapter 4 grant funds for programs to check helmet usage or to create checkpoints that specifically target motorcyclists.

POLICY ON SEAT BELT USE

In accordance with Executive Order 13043, Increasing Seat Belt Use in the United States, dated April 16, 1997, the Grantee is encouraged to adopt and enforce on-the-job seat belt use policies and programs for its employees when operating company-owned, rented, or personally-owned vehicles. The National Highway Traffic Safety Administration (NHTSA) is responsible for providing leadership and guidance in support of this Presidential initiative. POLICY ON BANNING TEXT MESSAGING WHILE DRIVING

In accordance with Executive Order 13513, Federal Leadership On Reducing Text Messaging While Driving, and DOT Order 3902.10, Text Messaging While Driving, States are encouraged to adopt and enforce workplace safety policies to decrease crashes caused by distracted driving, including policies to ban text messaging while driving company-owned or rented vehicles, Government-owned, leased or rented vehicles, or privately-owned vehicles when on official Government business or when performing any work on or behalf of the Government. States are also encouraged to conduct workplace safety initiatives in a manner commensurate with the size of the business, such as establishment of new rules and programs or re-evaluation of existing programs to prohibit text messaging while driving, and education, awareness, and other outreach to employees about the safety risks associated with texting while driving.
