**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, AMENDING ITS 2025-2026 FISCAL BUDGET AND APPROPRIATING STORM DRAIN DIF FUND BALANCE AND CAPITAL PROJECTS FUND BALANCE FOR BASELINE STORM DRAIN PROJECT, CITY PROJECT NO. 170700.**

**WHEREAS**, the budget for fiscal year 2025-2026 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

**WHEREAS**, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

**WHEREAS**, the City Manager may transfer appropriations between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES  
HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

**Section 1:** Authorize an appropriation of \$21,656,964.20 for the Baseline Storm Drain project, City Project No. 170700. This amount includes \$21,156,964.20 from the Storm Drain Development Impact Fee Fund balance, Account No. 22304720-53001 and \$500,000 from the Capital Projects Fund Account No. 33004720-53001.
