

NARRATIVE

ASSIGNMENT/ARRIVAL

On 2/2/2026, I (Officer K. Green) was assigned to and worked the uniformed patrol for the Rialto Police Department; I was driving a marked, black and white patrol vehicle, and I was wearing my department-issued uniform. At approximately 1239 hours, I was dispatched to 977 North Driftwood Avenue, in the city of Rialto, County of San Bernardino, in regards to a security check.

BACKGROUND INFORMATION

Prior to arriving at the incident location, I received information from dispatch that the reporting party (Charles Dutton, date of birth) stated that he could see footprints off the walls, and debris from the attic on the ground, and believed somebody was inside of the attic.

REPORTING PARTY CONTACT/INTERVIEW CHARLES DUTTON

I contacted Charles at the incident location; the following is a summary of his statements. This conversation was recorded using my Rialto Police Department-issued Axon body-worn camera, which was later uploaded into the Evidence.com system.

Charles stated that he resides in two homes; 977 North Driftwood Avenue is the home that he rents out to tenants. Charles stated that he was at the residence on Friday (1/30/2026) and saw footprints on the wall underneath the attic, which he believed were scaling the wall to gain access to the attic, to stay in the residence. Charles stated that he filed a report and saw the same thing again today. Charles stated that he believes the point of entry was the bathroom window, as it was not secured, and there was no glass stopping an outside person from entering the residence. Charles stated that he did desire prosecution if there were subjects found inside, and stated that, on Friday, when officers responded, there were transient items located in the attic, indicating somebody was staying there.

SUSPECT CONTACT

Upon initial observations, I peeked in the attic, only able to get a superficial view; I did not observe anybody inside. Charles wanted me to check the attic fully through the access in the garage. I asked Charles if I was able to step while inside of the attic, as I did not want the ceiling to cave in from the weight that was being applied to it; Charles gave me permission to step in the attic, and I went inside. While entering the attic, I did not see anybody, and continued walking north through the attic and observed a subject balled up against one of the attic walls. I ordered the subject to show me his hands, but the subject did not move. I took another step, and while taking that step, I felt the attic floor giving in, causing the attic floor to break; I lost my footing and landed on a beam that supported my weight. The subject was still on the beam, balled into a corner; I gave him multiple commands, to which he finally responded, and he was escorted out of the attic and was detained.

The man was identified as Erik Barreramejia conducted for Erik, which resulted in Erik being arrested a total of four times last year for PC459 – Burglary, PC602(O) – Trespassing, and H&S11550(A) – Under the Influence of a Controlled Substance. Erik also showed to be on county probation with a beginning probation of 12/18/2025, and a discharge date of 12/18/2027.

A records check was

conducted for Erik, which resulted in Erik being arrested a total of four times last year for PC459 – Burglary, PC602(O) – Trespassing, and H&S11550(A) – Under the Influence of a Controlled Substance. Erik also showed to be on county probation with a beginning probation of 12/18/2025, and a discharge date of 12/18/2027.

I contacted Charles and asked him if he desired prosecution against Erik residing in the attic without his permission; Charles stated, Yes, and signed a Private Person's Arrest Form. Erik was then placed under arrest.

ARREST

Erik was placed under arrest, and he was placed in the rear seat of my patrol vehicle to be later transported to the Rialto Police Department for processing.

PROBATION HOLD:

Lieutenant Smith contacted San Bernardino County Probation and obtained a probation hold for Barrera that was sent to West Valley Detention Center.

EVIDENCE

All Axon recordings and photographs have been tagged and uploaded into the evidence.com system.

DISPOSITION

Case cleared by arrest.

Erik was issued a citation (#174740) and was later transported to the West Valley Detention Center for further booking and processing. Erik signed a citation stating that he promised to appear at Rancho Cucamonga Superior Courthouse at approximately 0800 hours on 05/06/2026.

RECOMMENDATIONS

Forward a copy of the report to the District Attorney's Office for review and filing of charge PC602(O) – Trespassing against Erik Barreramejia.
