A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ACCEPTING THE OMNITRANS MEASURE I REGIONAL MOBILITY PARTNERSHIP (RMP) PROGRAM GRANT AND AMENDING ITS 2024-2025 FISCAL BUDGET

**WHEREAS**, the budget for fiscal year 2024-2025 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

**WHEREAS**, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

**WHEREAS,** the City Manager may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Accept the OmniTrans Continuing Partnership grant funds of \$497,671.82 for Fiscal Year 2024 and 2025;

Section 2: Authorize an increase in budgeted revenues in the amount of \$497,671.82 in 22838351-47536; and

## **Section 3:** Approve the following appropriations

- \$130,254.08 in Account No. 22388150-51001 for Fiscal Year 2024/2025 FY's operational costs for the OmniTrans Continuing Partnership; and
- \$37,758.3 in 22388150-51010, for Fiscal Year 2024/2025 operational costs for the OmniTrans Continuing Partnership; and
- \$90,831.22 in account 22388150-52021 for fiscal year 2024/2025 operational costs for the OmniTrans Continuing Partnership; and
