A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, AMENDING ITS 2025-2026 FISCAL BUDGET AND APPROPRIATING FROM FUND BALANCE FROM DISCRETIONARY DEVELOPER AGREEMENTS AND SAN BERNARDINO COUNTY FUNDS FOR THE PURCHASE OF THE MULTI-YEAR AXON OFFICER SAFETY PLAN 10 (OSP10).

WHEREAS, the budget for fiscal year 2025-2026 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

WHEREAS, the City Manager may transfer appropriations between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Authorize an appropriation of \$237,426.72 for the FY26 portion of the multi-year Axon Officer Safety Plan 10 from the General Fund Balance, funded by Discretionary Developer Agreements and San Bernardino County Funds.
