1 ORDINANCE NO. 1655 2 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIALTO. CALIFORNIA, AMENDING THE CITY'S CONFLICT OF INTEREST ORDINANCE (CITY OF RIALTO CODE OF ORDINANCES SECTION 3 2.48.140) AND CONFLICT OF INTEREST DISCLOSURE ORDINANCE 4 (CITY OF RIALTO CODE OF ORDINANCES SECTION 2.48.145). 5 WHEREAS, in June, 2019, a fiscal year-end audit identified conflict of interest concerns related to the City's federal program spending, and specifically with federal CDBG grants; and 6 7 WHEREAS, subsequent review of the City's conflict of interest ordinances and internal controls process identified several issues with these ordinances and processes; and 8 WHEREAS, Subsequent to the resolution of the initial conflict of interest, the federal Department of Housing and Urban Development (HUD) has requested that the 9 City update and strengthen its conflict of interest ordinance and internal controls process, to avoid similar future conflicts of interest; and 10 11 WHEREAS, this proposed new conflict of interest ordinance will minimize the potential for future conflicts of interest in the award of City contracts and grants, and in 12 particular, federal CDBG grants; and 13 WHEREAS, the substantive changes in this proposed new conflict of interest ordinance have been reviewed and approved by HUD. 14 NOW, THEREFORE, the City Council hereby finds, determines, and ordains as follows: 15 SECTION 1. The City Council hereby specifically finds that all the facts set forth 16 in the recitals above of this Ordinance are true and correct and incorporated herein. 17 **SECTION 2.** Amendment of the City of Rialto's conflict of interest ordinances is 18 necessary to bring the City's conflict of interest rules in line with best practices and would bring the City into compliance with HUD's request for additional conflict of interest 19 regulations and controls. 20 **SECTION 3.** The City Council hereby deletes existing City of Rialto Code of Ordinances section 2.48.140 in its entirety, and replaces it with the following: 21 (a) No covered person shall participate in the making of a grant or contract by the city in which the covered person has a conflicting interest. 22 (b) For purposes of this prohibition, the following definitions shall apply: 23 (1) A "covered person" includes any person who holds an elected or 24 appointed City office, a City officer, a City employee, and any person who 25 is a consultant to the City. (2) A "conflicting interest" includes, but is not limited to, those decisions 26 where: 27 (A) A covered person holds or has held within the previous twelve 28 months a position with a potential grant or contract recipient;

1	(B) A close relative of a covered person holds or has held within the previous twelve months a position with a grant or contract
2	recipient;
3	(C) A close relative of the spouse or domestic partner of a covered person holds or has held within the previous twelve months a position with a grant or contract recipient.
5	(3) "Position" includes the status of a member, employee, owner, paid or
6	unpaid officer of, paid or unpaid leadership position in, or had an ownership interest in, a grant or contract recipient.
7	(4) A "close relative" includes a spouse, parent, grandparent, child, grandchild, aunt, uncle, or cousin.
8	(5) "Participate in the making of a grant or contract" includes participation
9	in: drafting a solicitation or contract; negotiating, voting on, approving, or executing a grant or contract; discussion of same with any city officer or employee; or attempts in any way to influence the making of a grant or
	contract.
11	(c) This prohibition shall not apply to a contract let by written competitive bid
12	where the contract will be awarded to the person or entity who submits the lowest responsible and responsive bid.
13	(d) Except for the Mayor or a member of the City Council, a covered person may
14 15	request a waiver of any potential conflict of interest in writing from the City Manager. Any request for such a waiver must include full disclosure of the potential conflict of interest and a statement detailing any mitigating factors. The
16 17	request and the City Manager's response shall be provided to the City Council prior to any vote to approve the contract or grant, or if City Council approval is not required, at least five days before the contract or grant is approved. The request and the City Manager's response shall be considered a public record.
18	(e) The prohibitions in this section are in addition to any applicable federal or state
19	conflict of interest laws, including but not limited to Government Code section 1090, and Government Code section 87100 et seq.
20	(f) Any person who violates this section is subject to the following:
21	(1) Public censure;
22	(2) If the conflict of interest was in the making of a contract, a prohibition
23	from participation in the making of a contract by the city for a period of time up to twelve (12) months from the date of the imposition of the
24	discipline;
25	(3) If the conflict of interest was in the making of a grant, a prohibition from participation in the making of a grant by the city for a period of time
26	of up to twenty-four (24) months from the date of the imposition of the discipline;
27	(4) An administrative fine pursuant to Chapter 1.10 of this code.
28	(g) The discipline specified herein may be imposed:

2	(1) By the City Manager in the case of any employee or consultant who violates this section.
3	(2) By the City Council in the case of any person who holds an elected or appointed City office, or any City officer who violates this section.
5	SECTION 4. The City Council hereby deletes existing City of Rialto Code of Ordinances section 2.48.145 in its entirety, and replaces it with the following:
	(a) All persons or business entities supplying any goods or services to the city, or
7	seeking a loan or grant awarded by the city, whether through an application or proposal, shall disclose in such application or proposal whether any elected or appointed city official, city officer, employee, or consultant may have a financial
9	or non-financial interest in the person or business entity, or in any member, employee, owner, or officer of the business entity.
10	1. For purposes of this prohibition, a financial interest shall mean any
11	interest that is prohibited under state law, including California Government Code Sections 1090 and 87100, and California Code of Regulation Section 18700 et seq.

13	2. For purposes of this prohibition, a non-financial interest shall mean any interest that is prohibited by City of Rialto Code of Ordinances Section 2.48.140.
14	(h) In order to facilitate displaying as required by this scation, and and it will be
15	(b) In order to facilitate disclosure as required by this section, any such application or proposal to the City shall prominently include the following disclosure in any RFP or other solicitation document:

21   22	SECTION 5. The Mayor shall sign the passage and adoption of the Ordinance and thereupon the same shall take effect and be in force.
