A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ACCEPTING CALHOME FUNDING FROM THE CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT

WHEREAS, the budget for fiscal year 2025-2026 of the City of Rialto has been adopted by Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

WHEREAS, the City Manager may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Accept the funding from the California Department of Housing and Community Development (HCD) as follows: *Rialto Blueprint for Better Living: Mobile Home Repair Loan Program* \$1,200,000

Section 2: Amend FY2025-2026 budget to increase account number 22381850-47833 by \$200,000 for revenue related to administrative programming; and

Section 3: City staff has budgeted \$1,000,000 in account number 22381840-47833 for program revenue, \$1,000,000 in account 223818540-52011 for program expenses and \$200,000 in account 22381850-52011 for administrative expenses related to the *Rialto Blueprint for Better Living: Rialto Mobile Home Rehab Loan Program.*

Section 4: The City Clerk shall certify the adoption of this Resolution.
