3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
4 RIALTO, CALIFORNIA, DECLARING ITS INTENTION TO  
5 CONDUCT A PUBLIC HEARING ON JUNE 9, 2026, ON STREET  
6 LIGHT MAINTENANCE DISTRICT NO. 1, AND TO LEVY AND  
7 COLLECT ANNUAL ASSESSMENTS RELATED THERETO FOR  
8 FISCAL YEAR 2026/2027

8 WHEREAS, the City Council of the City of Rialto, California, (hereinafter the "City  
9 Council"), has by previous Resolution established the Street Light Maintenance District No. 1,  
10 pursuant to the provisions of the Landscaping and Lighting Act of 1972, Part 2 of Division 15  
11 of the Streets and Highways Code of the State of California, beginning with §22500  
12 (hereafter referred to as the "Act"), that provides for the levy and collection of assessments  
13 by the City of Rialto to pay for the maintenance and services of improvements and all  
14 appurtenant facilities and operations related thereto; and

15 WHEREAS, an Engineer's Report for Street Light Maintenance District No. 1,  
16 (hereafter referred to as the "Report"), has been prepared and filed with the City Clerk of the  
17 City of Rialto, (hereafter referred to as the "City Clerk"), and the Report identifies the levy of  
18 assessments for Fiscal Year 2026/2027 (July 1, 2026, and ending June 30, 2027) in  
19 accordance with the Act; and the City Council did by previous Resolution preliminarily  
20 approve the Report.

21 THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND,  
22 DETERMINE, AND RESOLVE AS FOLLOWS:

23 **Section 1:** The City Council hereby declares its intention to levy and collect annual  
24 assessments against parcels of land within Street Light Maintenance District No. 1 for Fiscal  
25 Year 2026/2027 in accordance with §22624 of the Act.

26 **Section 2:** The territory of land within Street Light Maintenance District No. 1  
27 includes all lots and parcels within the incorporated boundaries of the City of Rialto, and a full  
28 and complete listing of parcels within Street Light Maintenance District No. 1 is included in the

1 Report on file with the City Clerk.

2 **Section 3:** The improvements include the operation, maintenance and servicing of an  
3 existing street lighting and electrical system, and publicly maintained trees, and appurtenant  
4 facilities and improvements to be provided by the City of Rialto in connection with the  
5 improvements installed within Street Light Maintenance District No. 1. Detailed maps and  
6 descriptions of the location and extent of the improvements to be maintained are on file in the  
7 Office of Public Works and by reference are made part of this Resolution.

8 **Section 4:** The proposed assessments for Street Light Maintenance District No. 1  
9 are outlined in the Report. The Report details the assessments necessary to provide for the  
10 annual operation, administration, services and maintenance of the improvements described in  
11 Section 3 of this Resolution. These assessments are less than or equal to the maximum  
12 assessment amounts previously approved by property owner petition or balloting within Street  
13 Light Maintenance District No. 1, in accordance with the provisions of the California  
14 Constitution Article XIID (Proposition 218).

15 **Section 5:** The City Council hereby declares its intention to conduct a Public Hearing  
16 concerning the levy of assessments for the improvements in accordance with §22625 of the  
17 Act. Any interested person may file a written protest with the City Clerk prior to the conclusion  
18 of the hearing, or having previously filed protest, may file a written withdrawal of that protest. A  
19 written protest shall state all grounds of objection and protest by a property owner shall contain  
20 a description sufficient to identify the property owned by such property owner. At the Public  
21 Hearing, all interested persons shall be afforded the opportunity to hear and be heard.

22 **Section 6:** Notice is hereby given that a Public Hearing on these matters will be held  
23 by the City Council on Tuesday, June 9, 2026, at 6:30 P.M., or as soon thereafter as feasible in  
24 the City Council Chambers at City Hall, located at 150 South Palm Avenue, Rialto, California.

25 **Section 7:** In accordance with §22552 and §22553 of the Act, the City Clerk shall  
26 cause notice to be given of the time and place of the Public Hearing by causing the publishing  
27 of this Resolution once in the local paper not less than ten (10) days before the date of the

1 Public Hearing, and by posting a copy of this Resolution on the official bulletin board  
2 customarily used by the City Council for the posting of such notices, pursuant to the Act.

3 **WHEREFORE**, this Resolution is passed, approved and adopted this 26<sup>th</sup> day of May  
4 2026.
