PUBLIC HEARINGS

Conditional Development Permit No. 2018-0042

Associate Planner Daniel Rosas presented Conditional Development Permit No. 2018-0042 a request to allow the operation of a tire and rim shop within an existing commercial building located at 260 East Foothill Boulevard (APN: 0127-602-15, -16, and -18) within the Commercial Pedestrian (C-P) zone of the Foothill Boulevard Specific Plan.

The operations of the tire and rim shop include sales, installation, and storage of tires only within the enclosed building. The hours of operation are 8am to 6pm Monday through Saturday and no vehicles will be parked on-site outside of hours of operation. One delivery truck is permitted on-site within a designated parking space located at the rear of the property.

The Development Review Committee preliminary reviewed the project on February 20, 2019 and provided comments for the proposed project.

The shop meets or exceeds all criteria of the C-P zone of the Foothill Boulevard Specific Plan, as well as the Design Guidelines. It is also consistent with Goal 3-1 of the Land Use Element and Economic Development Element of the General Plan. In addition, it is Class 1

Categorical Exempt from CEQA (California Environmental Quality Act) as it is an existing facility.

Staff recommends approval of the project.

Chair Peukert opened the Public Hearing.
