A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO. CALIFORNIA. APPROVING THE **PUBLIC** IMPROVEMENT AGREEMENT FOR PUBLIC IMPROVEMENTS ALONG DURST DRIVE RELATED TO THE PRECISE PLAN OF DESIGN (PPD) 2022-0047 FOR THE DEVELOPMENT OF 1.87 36,500 **SQUARE-FOOT** ACRES WITH INDUSTRIAL WAREHOUSE BUILDING AND **ASSOCIATED** PAVING. LANDSCAPING, SCREEN WALLS, LIGHTING, AND DRAINAGE IMPROVEMENTS.

WHEREAS, the Planning Commission of the City of Rialto, at its meeting of November 8, 2023, approved PPD 2022-0047 subject to conditions; and

WHEREAS, SDG HOLDINGS, LLC (hereinafter the "Developer"), has submitted a Public Improvement Agreement with security; and

WHEREAS, not all public improvements have been completed by the Developer prior to issuance of building permits, and the Developer has requested that the City enter into a Public Improvement Agreement with the Developer to secure the cost of public improvements.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Requisite conditions associated with PPD 2022-0047 have been satisfied or supported with the necessary security for construction of improvements.

Section 2: The City Council hereby approves a Public Improvement Agreement for PPD 2022-0047 with the Developer and accepts public improvement securities in conformance with the requirements therein for public improvements. The City Manager is hereby authorized to execute the Public Improvement Agreement on behalf of the City.

<u>Section 3:</u> The City Clerk shall cause to have recorded with the San Bernardino County Recorder the Public Improvement Agreement.
