Mayor Pro Tem Scott commented that the statement made related to the prior City Council authorizing the rate increases to Prop. 218 is misleading. He stated that the City Council accepted the results of Prop. 218.

He asked that the Prop. 218 process be explained to the community who do not understand the process and what the outcome was.

Mr. Heftman stated that the Prop. 218 process is mandated by the State. When rates are changing, notification to the public is required. The requirement can be sent out to the public for no more than five years. You can estimate rates or five-year periods. Those rates would be considered not to exceed rates. If there is opposition that is presented to the City during Prop. 218 to put down the adjusted rate Prop. 218 notification process, there needs to be more than 50 percent of personal owners throughout the City, it would be required to turn down the Prop. 218 notice. In 2023, he does not recall that level was met.

Mr. Coleman stated there are different testing levels of Unregulated Contaminant Monitoring Rule, UCMR 1,2,3 and 4. During the UCMR 3, all sources inside the City of Rialto were sampled for PFAS. The only one that came up, was Rialto Well 5. That was inactive. It never ran into the system.

The State of California compiled a list and a whole sampling plan for all wells and water agencies within the State of California. More information can be found on the DDW website.

Rialto Well 5 had a PFAS detection. That well is off.
