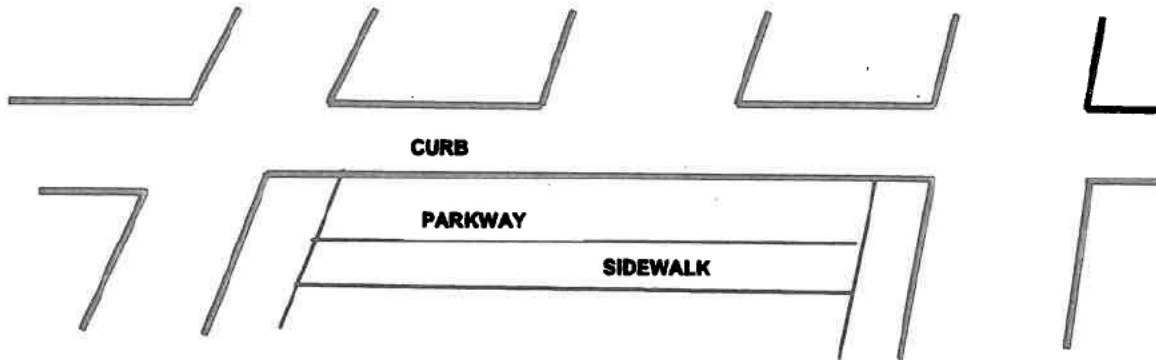

Authorization for release of impounded vehicles must be obtained from the Rialto Police Department 128 N. Willow Avenue, Rialto, CA 92376 (909) 820-2578. You may recover possession of your stored vehicle by fulfilling the following requirements:

- Paying to the Rialto Police Department a release fee of two hundred sixteen dollars and eighty cents. (\$216.80).
- The registered owner of the vehicle must be present with a valid driver's license, or have a valid licensed driver with them at the time of release.
- Provide proof of current registration and insurance on the vehicle.
- Pay all towing and storage fees at the tow yard. The Rialto Police Department has no authority over fees charged by the tow company.

If you believe you have cause to dispute this impound, you may request a post-storage hearing. This departmental hearing will determine whether there was a sufficient legal basis for impounding your vehicle.

A hearing request must be received by this agency within ten (10) days from the date of this notice. Hearing requests may be submitted in person, by mail to Rialto Police Department 128 N. Willow Avenue, Rialto, CA 92376, or by telephone at (909) 820-2578.

This hearing must be held within forty-eight (48) hours of your request * (Excluding weekends and holidays)

Failure to request or attend a scheduled hearing shall satisfy the post-storage validity hearing requirements of California Vehicle Code Section 22852.

Please note these procedures DO NOT affect any related traffic citations or other criminal proceedings. If you wish to challenge underlying charges such as a citation or other criminal proceeding, you must do so at the appropriate court.
