

1 **WHEREAS**, on August 4, 2021, the City Manager, serving as the Director of Emergency Services,
2 pursuant to Resolution No. 7600, issued Emergency Order No. 2021-01 attached hereto, requiring
3 masking for all persons in City of Rialto owned or controlled facilities, within the jurisdictional boundaries
4 of the City of Rialto beginning August 4, 2021; and

5 **WHEREAS**, the Council deems it necessary to ratify and confirm the issuance of Emergency
6 Order No. 2021-01 requiring masking of all persons in City of Rialto owned or controlled facilities
7 beginning August 4, 2021; and

8 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY**
9 **FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

- 10 1. That the recitals set forth hereinabove and set forth in Emergency Order No. 2021-01 are true and
11 correct in all respects.
- 12 2. The City Council has reviewed the need for requiring masking of all persons in City of Rialto
13 owned or controlled facilities and requires ratification of Emergency Order No. 2021-01.
- 14 3. The issuance of Emergency Order No 2021-01, as issued by the Director of Emergency Services
15 on August 4, 2021, attached hereto, is hereby ratified and confirmed.
- 16 4. Emergency Order No. 2021-01 shall be in effect until terminated by the Director of Emergency
17 Services or by the City Council of the City of Rialto, whichever is the first to occur.
