

1 treatment, or disposal of wastewater originating in the Service Area and any extensions, expansions, or
2 replacements of any of the above being hereinafter referred to as the “Rialto Disposal System”; and
3

4 WHEREAS, City has defined and established by Council Resolution a policy and
5 administrative guidelines to provide for wastewater service outside the City’s corporate boundaries;
6 and
7

8 WHEREAS, in order to accommodate the conveyance, treatment and disposal of wastewater
9 originating in the Service Area, City has agreed to maintain and/or construct the Rialto Disposal System
10 and such related and/or additional facilities as may be necessary to adequately provide such service for
11 the Service Area in perpetuity; and
12

13 WHEREAS, in consideration of City’s agreement to provide adequate conveyance, treatment
14 and disposal services to the Service Area, Owners have agreed to make payments described in an
15 Extraterritorial Wastewater Service Agreement with respect to wastewater from the Property
16 discharged into the Rialto Disposal System (such wastewater being “Service Area Wastewater”)
17 calculated at one point three (1.3) times the monthly rates charged by City to customers within Rialto,
18 all on terms and conditions more fully set forth therein.

20 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF
21 RIALTO AS FOLLOWS:
22

23 Section 1. An Extraterritorial Wastewater Service Agreement (the “Agreement”) authorizing
24 wastewater service to the Mobile Home Park located at 10701 Cedar Avenue, Bloomington, CA, on the
25 east side of Cedar between Santa Ana Avenue and Slover Avenue, identified by Assessor Parcel Number
26 0257-041-12 and 0257-041-23, is hereby approved as submitted to the City Council concurrently with its
27 adoption of this Resolution.
