### IT IS HEREBY AGREED AS FOLLOWS:

#### AMENDMENT NO. 4

It is hereby agreed to amend contract No. 14-614, effective July 1, 2018, as follows:

#### III. FISCAL PROVISIONS

Paragraph A is amended to read as follows:

- A. The maximum amount of reimbursement under this Contract shall not exceed \$1,546,060. The consideration to be paid to County, as provided herein, shall be full payment for all County's services and expenses incurred in the performance hereof, including travel and per diem. The maximum amount is a total dollar amount that includes the original contract amount and all subsequent amendments, broken down as follows:

Amendment No. 1	\$303,078	July 1, 2015 through June 30, 2016
Amendment No. 2	\$303,078	July 1, 2016 through June 30, 2017
Amendment No. 3	\$309,139	July 1, 2017 through June 30, 2018
Amendment No. 4	\$327,687	July 1, 2018 through June 30, 2019

**V. TERM**

Section V is amended to read as follows:

This Contract is effective as of July 1, 2014, and is extended from its amended expiration date of June 30, 2018, to expire on June 30, 2019, but may be terminated earlier in accordance with provisions of Section VI of the Contract.

**All other terms and conditions remain in full force and effect.**
