3 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**  
4 **RIALTO, CALIFORNIA, AUTHORIZING THE SUBMITTAL OF AN**  
5 **APPLICATION FOR THE SAFE STREETS AND ROADS FOR**  
6 **ALL (SS4A) IMPLEMENTATION GRANT AND AUTHORIZING**  
7 **THE CITY MANAGER OR DESIGNEE TO EXECUTE ALL**  
8 **RELATED DOCUMENTS**

9 **WHEREAS**, the U.S. Department of Transportation (USDOT) has announced the  
10 availability of grant funding through the Safe Streets and Roads for All (SS4A) program to  
11 support regional and local initiatives that prevent roadway deaths and serious injuries; and

12 **WHEREAS**, on September 13, 2022, the City Council of the City of Rialto authorized  
13 submission of a grant application to develop a Safety Action Plan, and the City was awarded  
14 \$320,000 in SS4A funds to complete this plan; and

15 **WHEREAS**, on January 9, 2024, the City Council approved a professional services  
16 agreement with Kimley-Horn and Associates, Inc. to prepare the Safety Action Plan; and

17 **WHEREAS**, the Safety Action Plan identifies critical safety improvements and  
18 strategies aimed at eliminating roadway fatalities and serious injuries through a  
19 comprehensive Safe System Approach; and

20 **WHEREAS**, the City is eligible to apply for the FY 2025 SS4A Implementation Grant  
21 to fund infrastructure and operational improvements that align with the Safety Action Plan;  
22 and

23 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF**  
24 **RIALTO AS FOLLOWS:**

25 **Section 1:** The City Council hereby authorizes staff to submit a grant application to  
26 the U.S. Department of Transportation for the Safe Streets and Roads for All (SS4A)  
27 Implementation Grant.

28 **Section 2:** The City Council authorizes the City Manager, or their designee, to  
execute all necessary documents related to the grant application and, if awarded, to take any  
actions necessary to implement the grant-funded project.
