3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 RIALTO, CALIFORNIA, TO ACCEPT ADDITIONAL HIGHWAY
5 SAFETY IMPROVEMENT PROGRAM (HSIP) CYCLE 8 GRANT
6 FUNDS FOR THE CONSTRUCTION OF THE MEDIAN ISLAND
7 ON BASELINE ROAD BETWEEN WILLOW AVENUE AND
8 PEPPER AVENUE, APPROPRIATE LOCAL MEASURE I FUNDS,
9 AND AMENDING THE FISCAL YEAR 2023-2024 BUDGET.

10 **WHEREAS**, the budget for fiscal year 2023-2024 of the City of Rialto has been
11 adopted by this Council in its original form, and said budget will need to be amended at times
12 to fulfill the goals of the City; and

13 **WHEREAS**, the City departments may not exceed their appropriations by character of
14 expense, with character of expense being defined as personnel services, services and
15 supplies, capital outlay, debt service and transfers, without the consent of the City
16 Administrator; and

17 **WHEREAS**, the City Administrator may transfer appropriations, between departments
18 and within their respective funds, as long as those appropriations do not exceed their fund
19 total unless approved by Council.

20 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES**
21 **HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

22 **Section 1:** Approve an increase in estimated revenues in the amount of \$577,710
23 to the Grants Project Fund, Account Number 22234420-47536; and

24 **Section 2:** Authorize the appropriation of \$842,738 from
25 Grants Project Fund, Account Number; 22234420-53001-170812-05 for \$540,630; and
26 Grants Project Fund, Account Number; 22234420-53001-170812-16 for \$37,080; and
27 Measure I Fund, Account Number; 22014310-53001-170812-04 for \$37,520; and
28 Measure I Fund, Account Number; 22014310-53001-170812-15 for \$13,620; and
Measure I Fund, Account Number; 22014310-53001-170812-22 for \$213,888

1 For the construction of the Median Island on Baseline Road between Willow Avenue and
2 Pepper Avenue, project expenditures.
