**RESOLUTION NO. 7563**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO FINDING THAT THE PUBLIC PURPOSE WOULD BE SERVED BY THE PROVISION OF CITY RESOURCES AND FUNDING FOR SPECIFIED SPECIAL EVENTS AND APPROVES SUCH SPECIFIED SPECIAL EVENTS FOR FISCAL YEAR 2019-2020**

**WHEREAS**, the City Council of the City of Rialto adopted in whole or part certain Special Events that were placed on a City-wide Special Events calendar, which events are listed in Exhibit “A” to this Resolution and are intended to approximate those special events and costs which have been adopted and/or accepted as either a City event or co-sponsored event; and

**WHEREAS**, there are events identified and approved in the 2019-2020 budget, that have taken place prior to this City Council consideration and must retroactively be approved by this resolution; and

**WHEREAS**, the City Council is advised that if the City of Rialto is to expend public funds in whole or part, the event should serve a public purpose and be formally approved by City Council, including any funding or in-kind contributions for same; and

**WHEREAS**, if funds are used for a public purpose of the city making the expenditure, they are not a gift within the meaning of Cal Const art XVI, §6. (*County of Alameda v Janssen* (1940) 16 C.2d 276, 281.); and

**WHEREAS**, events listed on the Special Events Calendar are scheduled to be held within the City as a part of the City’s larger scope of events; some may not be organized by the City, but are scheduled on the calendar because of a collaborative effort, an historical significance, and/or by the City having taken a role as a co-sponsor; and

**WHEREAS**, the Special Events for 2019-2020, as listed in Exhibit “A” hereto, are intended to be a guide for the members of City Council in its deliberations to decide whether the events as stated and/or amended will continue to be a part of the 2019-2020 calendar of special events; and

**WHEREAS**, by this Resolution, the City Council wishes to approve those Special Events for 2019-2020, as listed in Exhibit “A” and find that each event serves the legitimate public purpose(s) stated therein.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA AS FOLLOWS:**
