

NOTICE OF PUBLIC HEARING IN CONNECTION WITH THE CITY OF RIALTO REFUSE COLLECTION SERVICE CHARGES

NOTICE IS HEREBY GIVEN that on June 27, 2023, at 6:30 p.m., or as soon thereafter as practicable, in the City Hall, Council Chambers, 150 S. Palm Avenue, Rialto, CA 92376, the City Council of the City of Rialto will hold a public hearing concerning increased charges for refuse collection services.

INFORMATION ABOUT THE CHARGES

A. Basis upon which the charges were calculated – The City Council has previously determined that the collection and disposal of solid waste in the City is a service to be performed by a private company, under an exclusive franchise agreement. The service charges adopted by the City include a monthly charge for automated curbside and bin collection. The charges represent the amount the City has negotiated with the private company for solid waste collection services. In accordance with state law, the public hearing will include consideration of adopting a resolution that will authorize the City to pass through solid waste increases for the period commencing on July 1, 2023, through June 30, 2027. Such increases must not exceed the estimated rates included with this notice and must be substantiated by the consumer price index and the disposal and processing pass through costs and program costs.

The monthly residential curbside collection charge is comprised of six components: (1) an amount for the administration and operation of the automated curbside refuse collection service, which includes the provision of three collection carts; option of either a 40 or 60-gallon refuse cart, one 60-gallon recycling cart and one 60-gallon organics cart, with weekly pick-up service, (2) an amount for the hauler to dispose of the refuse and recyclable materials (the "tipping fee"), (3) an amount to operate the curbside bulky item collection service, (4) an amount to implement state diversion and compliance mandates related to SB 1383 organics and recyclables diversion programs such as compliance monitoring, compost procurement, recordkeeping, edible food recovery, contamination monitoring, and ongoing education, (5) an amount for the administration and operation of State mandated environmental programs (HHW and AB939), and (6) an amount to compensate the City for its administrative costs in connection with the services (the "franchise" fee).

The commercial collection charge is comprised of five components: (1) an amount for the administration and operation of commercial bin refuse collection service, (2) an amount for the hauler to dispose of the refuse and recyclable materials (the "tipping" fee), (3) an amount for the hauler to operate commercial and multi-family recycling bin collection services to comply with AB341 (the "recycling" fee) and food recycling services to comply with SB1383 (the "FW fee"), (4) an amount to implement state diversion and compliance mandates related to SB 1383 organics and recyclables diversion programs such as compliance monitoring, compost procurement, recordkeeping, edible food recovery, contamination monitoring, and ongoing education (the "compliance fee"), (5) an amount to collect and dispose of multi-family bulky items (the "Bulky fee"), (6) an amount to compensate the City for its administrative costs in connection with the services and to provide State mandated environmental programs (the franchise fee, AB939 fee and HazMat fee).

B. Reason for the charges – The City uses the solid waste collection charges for the operation and administration of the refuse disposal, recycling and household hazardous waste programs. The proposed increase per month represents the additional costs as negotiated with the franchisee, to provide automated barrel and bin collection services, refuse, recycling, organic and residential curbside and multi-family bulky item collection service. The proposed increase represents the amount, which will be finalized at the public hearing.

C. Charge per parcel – The City proposed to adopt a new resolution that establishes the 2023-2024 residential, multi-family and commercial charges and to increase the residential refuse collection charges as follows:

The City also proposes to increase the charges for residential bin service, commercial and multi-family bin service and roll-off service. WRITTEN REPORT

The City has caused a written report to be prepared and filed with the City Clerk regarding the proposed new commercial and residential refuse collection service charge. As required by California Government Code Section 66016, the written report also provides data indicating the amount of cost, or estimated cost, to provide refuse collection service and the revenue sources anticipated to provide the service. A copy of the written report will be available at the City Clerk's office at 290 West Rialto Avenue, Rialto, CA, on June 27, 2023.

PUBLIC HEARING

At the public hearing, the City Council will hear and consider all objections or protests to the proposed estimated rate increases. Requests to speak regarding the proposed rates must be filed with the City Clerk prior to the conclusion of the public hearing item. Written protests may be delivered to the City Clerk at the public hearing or mailed or delivered to the City Clerk, Rialto City Hall, 150 S. Palm Avenue, Rialto, CA, 92376. Protests, which are mailed or delivered to City Hall, must arrive at City Hall prior to 3:00 p.m. on June 27, 2023, to be counted.
