I am writing to express my interest in serving as a Rialto City Council Member. I believe my lifelong commitment to public service, my professional expertise, and my deep connection to Rialto make me uniquely qualified to help our city grow in a way that benefits every resident. Over the years, I have dedicated myself to addressing challenges such as mental health needs and housing insecurity—work I pursue not out of obligation, but from a genuine desire to see Rialto thrive. Serving on the City Council is a natural extension of this commitment, allowing me to advocate for policies that will improve the lives of our neighbors.

As a Licensed Marriage and Family Therapist with over 15 years of experience, I have also served as a Clinical Supervisor at Victor Community Support Services for the past six years. This role has expanded my understanding of how underfunded mental health services and limited preventive care contribute to homelessness, strained family dynamics, and restricted access to critical resources. I believe these insights position me to champion comprehensive mental health programs at the city level, emphasizing prevention, cultural competency, and early intervention. Beyond mental health advocacy, I have been actively involved in community organizing. I founded the Juneteenth Jam to celebrate Black history and culture, and launched "Black on the Block," now known as Rialto City Jam, to uplift small local businesses. For the past four years, I have also co-chaired Rialto Men's Health Awareness, collaborating with healthcare professionals to promote wellness among men in our city. Additionally, I organize the annual Tour of Toys giveaway throughout the Inland Empire, with a stop in Rialto for the past three years, partnering with local organizations, schools, and community centers to support families in need.

I currently serve as the CFO of Stronger Together Now, a youth empowerment organization that equips young people with essential skills, and I sit on the board of Tomorrow's World Housing Program, where we provide affordable mental health housing and support for vulnerable populations.

Ultimately, I am running for City Council to ensure the voices of our diverse community are heard. I envision a Rialto where families prosper, young people have abundant opportunities, and mental and physical well-being are prioritized. Through collaboration with fellow council members, community leaders, and residents, I hope to bring fresh ideas, compassionate leadership, and a focus on equity to the table. Together, we can build a stronger Rialto that truly serves everyone who calls it home.
