RESOLUTION NO. 7169 1 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF 2 RIALTO, CALIFORNIA, APPROVING RESIDENTIAL REFUSE COLLECTION SERVICE CHARGES BE COLLECTED ON THE 3 PROPERTY TAX ROLL. 4 WHEREAS, the City of Rialto is a municipal corporation duly organized and existing pursuant 5 to the Constitution of the State of California (hereinafter the "City"); and 6 WHEREAS, on April 25, 2017, the City adopted Resolution No. 7116 which established 7 increased rates for residential and commercial refuse collection services; 8 WHEREAS, billing residential refuse collection service charges on the property tax roll will 9 defray the costs of the aforementioned increased rates for refuse collection services; 10 WHEREAS, City Municipal Code Section 8.08.140(F) provides that the City may employ any 11 method provided by state law for collection of refuse collection service charges; 12 WHEREAS, Health & Safety Code section 5470 et seq. sets forth a procedure that authorizes 13 the City to have such charges collected on the tax roll with the general taxes; and 14 WHEREAS, the City Council of the City of Rialto now desires to elect to have residential 15 refuse collection charges collected on the tax roll in the same manner, by the same persons, and at the 16 same time as, together with and not separately from, its general taxes. 17 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS: 18 19 The above recitals are all true and correct. Section 1. 20 Residential refuse collection charges shall, from this date forward, be collected on Section 2. 21 the tax roll in the same manner, by the same persons, and at the same time as, together with and not 22 separately from, its general taxes. The City shall cause a written report to be prepared each year and 23 filed with the City Clerk, which shall contain a description of each parcel of real property receiving

Section 3. This Resolution shall remain in effect until repealed.
