

1 extensions, expansions, or replacements of any of the above being hereinafter referred to as the “Rialto
2 Disposal System”; and

4 WHEREAS, Rialto Utility Authority has defined and established by Resolution a policy and
5 administrative guidelines to provide for wastewater service outside the City’s corporate boundaries;
6 and

7
8 WHEREAS, in order to accommodate the conveyance, treatment and disposal of wastewater
9 originating in the Service Area, Rialto Utility Authority has agreed to maintain and/or construct the
10 Rialto Disposal System and such related and/or additional facilities as may be necessary to adequately
11 provide such service for the Service Area in perpetuity; and

12
13 WHEREAS, in consideration of Rialto Utility Authority’s agreement to provide adequate
14 conveyance, treatment and disposal services to the Service Area, Owner have agreed to make payments
15 described in an Extraterritorial Wastewater Service Agreement with respect to wastewater from the
16 Property discharged into the Rialto Disposal System (such wastewater being “Service Area
17 Wastewater”) calculated at one point three (1.3) times the monthly rates charged by City to customers
18 within Rialto, all on terms and conditions more fully set forth therein.

20 NOW, THEREFORE, BE IT RESOLVED BY THE RIALTO UTILITY AUTHORITY OF
21 THE CITY OF RIALTO AS FOLLOWS:

23 Section 1: An Extraterritorial Wastewater Service Agreement (the “Agreement”) authorizing
24 wastewater service to the Mobile Home Park located at 10701 Cedar Avenue, Bloomington, CA, on the
25 east side of Cedar between Santa Ana Avenue and Slover Avenue, identified by Assessor Parcel Number
26 0257-041-12 and 0257-041-23, is hereby approved as submitted to the Rialto Utility Authority
27 concurrently with its adoption of this Resolution.
