**Commissioner Sandoval:** Attended staff training. Thank you Cynthia, it was nice to meet the staff and learn new things. Love to attend again. Had a chance to participate in activities at the park. Participated with the Tree people. Route 66, video? Showcasing city and business on route 66. With the plan there will be a lot of surveys we can be champions for the outreach and support.
