3 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**  
4 **RIALTO, CALIFORNIA, ORDERING THE PREPARATION OF AN**  
5 **ENGINEER’S REPORT FOR LANDSCAPING AND LIGHTING**  
6 **DISTRICT NO. 2 TO ESTABLISH ANNUAL ASSESSMENTS**  
7 **FOR FISCAL YEAR 2025/2026.**

8 **WHEREAS**, the City Council of the City of Rialto, California, (hereinafter the “City  
9 Council”), has by previous Resolution established the Landscaping and Lighting District No. 2  
10 pursuant to the provisions of the Landscaping and Lighting Act of 1972, Part 2 of Division 15  
11 of the Streets and Highways Code of the State of California, beginning with §22500  
12 (hereafter referred to as the “Act”), that provides for the levy and collection of assessments  
13 by the City of Rialto to pay for the maintenance and services of improvements and all  
14 appurtenant facilities and operations related thereto; and

15 **WHEREAS**, §22566 and §22622 of the Act requires the preparation of an Engineer’s  
16 Report to determine and adjust the annual assessment rates for Landscaping and Lighting  
17 District No. 2.

18 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES**  
19 **HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

20 **Section 1:** Webb Municipal Finance, LLC is hereby ordered to prepare and  
21 appropriately file the Engineer’s Report required to determine and adjust the Landscaping  
22 and Lighting District No. 2 assessments for Fiscal Year 2025/2026 in accordance with  
23 §22566 and §22622 of the Act. The Engineer’s Report shall be filed with the City Clerk for  
24 submission to the City Council.

25 **Section 2:** The improvements to be operated and maintained by Landscaping and  
26 Lighting District No. 2 generally include the operation, administration, maintenance, and  
27 servicing of streetscape landscaping including parkways and medians as well as public  
28 landscaped areas, including turf, ground cover, plants, shrubs, trees, irrigation and drainage  
systems, street lighting improvements, and appurtenant facilities and expenses associated

1 with Landscaping and Lighting District No. 2 that will be maintained by the City of Rialto  
2 through annual assessments.

3 **Section 3:** The improvements to be maintained by the City of Rialto for Fiscal Year  
4 2025/2026 are substantially the same as the improvements provided and maintained in the  
5 previous Fiscal Year and the Engineer’s Report for Landscaping and Lighting District No. 2  
6 prepared in connection therewith shall describe the improvements as required by the Act.

7 **Section 4:** The Engineer’s Report for Landscaping and Lighting District No. 2 shall  
8 reflect provisions and related assessments in accordance with the requirements of Articles  
9 XIIC and XIID of the California Constitution as enacted by the passage of Proposition 218,  
10 also referred to as “The Right to Vote on Taxes Act,” as approved by the voters of the State of  
11 California on November 5, 1996.

12 **Section 5:** The Engineer’s Report for Landscaping and Lighting District No. 2 shall  
13 be titled: “City of Rialto, Landscaping and Lighting District No. 2, 2025/2026 Engineer’s Annual  
14 Levy Report.”

15 **Section 6:** The City Clerk shall certify to the adoption of this Resolution.
