3 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO,**
4 **CALIFORNIA, AUTHORIZING THE GRANT APPLICATION,**
5 **ACCEPTANCE AND EXECUTION FOR THE WELL "CITY 3A"**
6 **GROUNDWATER TREATMENT SYSTEM PROJECT.**

8 WHEREAS, City of Rialto proposes to implement the Well "City 3A" Groundwater
9 Treatment System Project;

10 WHEREAS, City of Rialto has the legal authority and is authorized to enter into a funding
11 agreement with the State of California; and

12 WHEREAS, City of Rialto intends to apply for grant funding from the California
13 Department of Water Resources for the Well "City 3A" Groundwater Treatment System Project;

14 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES**
15 **HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

16 **Section 1:** That pursuant and subject to all of the terms and provisions of Budget Act
17 of 2021 (Stats. 2021, ch. 240, § 80), the City of Rialto City Manager, or designee is hereby
18 authorized and directed to prepare and file an application for funding with the Department of
19 Water Resources and take such other actions necessary or appropriate to obtain grant funding.

20 **Section 2:** The City of Rialto City Manager, or designee, is hereby authorized and
21 directed to execute the funding agreement with the Department of Water Resources and any
22 amendments thereto.

23 **Section 3:** The City of Rialto City Manager, or designee, is hereby authorized and
24 directed to submit any required documents, invoices, and reports required to obtain grant
25 funding.
