## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, APPROVING TRACT MAP 20204 FOR THE SUBDIVISION OF LAND INTO 130 RESIDENTIAL LOTS TO FACILITATE THE DEVELOPMENT OF THE LYTLE CREEK RANCH SPECIFIC PLAN MASTER PLANNED COMMUNITY; AND APPROVING AN ASSOCIATED SUBDIVISION IMPROVEMENT AGREEMENT.

WHEREAS, the Planning Commission of the City of Rialto, at its meeting of May 25, 2022, approved Tentative Tract Map 20204 subject to conditions; and

WHEREAS, AG ESSENTIAL HOUSING CA 4, LP, a Delaware Limited Partnership, (hereinafter the "Subdivider"), has filed Tract Map 20204 with the City Council of the City of Rialto, (hereinafter the "City"), in accordance with Section 66456 of the California Government Code; and

WHEREAS, the Subdivider offers for dedication to the City of Rialto, the public in general, and public utility companies, an easement for streets and public utility purposes in, under, over, through and across Alpine Way, Bacon Ridge Way, Bridgeport Drive, Briggs Road, Calderwood Lane, Colorado Drive, Emerald Bay Drive, Holston Street, Hunter Drive, Lake Mendoza Street, Lone Pine Drive, and Oakflat Drive, subject to improvement, as shown on Tract Map 20204; and

**WHEREAS,** the Subdivider offers for dedication to the City of Rialto, a 3 feet wide public access and utility easement over Lots 1 through 130, inclusive, and Lots "A", "B", and "C," for the use of the public in general and the several public utility companies authorized to serve within the Tract; and

**WHEREAS**, the Subdivider offers for dedication to the City of Rialto, a 20 feet wide easement for access and maintenance of water appurtenances through Lot "C"; and

**WHEREAS**, not all public improvements have been completed by the Subdivider as of the filing of Tract Map 20204, and the Subdivider has requested that the City enter into a

Subdivision Improvement Agreement with the Subdivider to secure the cost of public improvement in accordance with Section 66462 of the California Government Code.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Tract Map 20204 is in substantial conformance with the approved Tentative Tract Map 20204

Requisite conditions associated with Tentative Tract Map 20204 have Section 2: been satisfied.

Section 3: Tract Map 20204 is in conformance with the General Plan.

Tract Map 20204 conforms to all applicable requirements of the Section 4: Subdivision Map Act of the State of California.

In accordance with Section 66477.1 of the California Government Code, the offers of dedication to the public on Tract Map 20204 shall be accepted by the City Clerk, subject to improvement, who shall certify acceptance by signature on the map thereof.

Section 6: The City Council hereby approves a Subdivision Improvement Agreement for Tract Map 20204 with the Subdivider's designee, Lennar Homes of California, LLC, a California limited liability corporation, and accepts subdivision improvement securities in conformance with the requirements therein for public improvements. The City Manager is hereby authorized to execute the Subdivision Improvement Agreement on behalf of the City.

The City Clerk shall cause to have recorded with the San Bernardino Section 7: County Recorder the Subdivision Improvement Agreement.

Section 8: Tract Map 20204 is hereby approved for the purposed therein defined.
