A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ACCEPTING THE OMNITRANS MEASURE I REGIONAL MOBILITY PARTNERSHIP (RMP) PROGRAM GRANT AND AMENDING ITS 2022-2023 FISCAL BUDGET

WHEREAS, the budget for fiscal year 2022-2023 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

WHEREAS, the City Manager may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Accept the OmniTrans Measure I Regional Mobility Partnership (RMP) Program Grant providing grant funds of \$228,741 for Fiscal Year 2022/2023 and grant funds of \$249,253 for Fiscal Year 2023/2024.

Section 2: Authorize an increase in the budgeted revenues in the amount of \$228,741 for year one of the grant in Account no. 283-400-8351-7536; and

Section 3: Allocate the grant funds for expenditures in the 2022/2023 budget: \$13,165 in Account no. 283-500-8351-1010 for a part time driver, \$27,382 for a full-time driver in Account no. 283-500-8351-1001, \$15,105 in Account 283-500-8351-1050 for benefits, \$27,386 for services and supplies, and \$145,702 in Account no. 283-500-8351-3050 for the purchase of two vehicles (one ADA).
