A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ACCEPTING ADDITIONAL FUNDING FROM FY 2021 HOMELAND SECURITY GRANT PROGRAM (HSGP) AND AMENDING ITS 2022-2023 FISCAL BUDGET

WHEREAS, the budget for fiscal year 2022-2023 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Manager; and

WHEREAS, the City Manager may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

Section 1: Accept additional funding from the FY2021 Homeland Security Grant Program (HSGP).

Section 2: Authorize an increase in estimated revenues in the amount of \$25,965 in HSGP, Account No. 247-400-6992-7560; and

Section 3: Approve an appropriation of \$25,965 in HSGP Fund, Account No. 247-500-6992-2021 for the FY2021 Homeland Security Grant Program (HSGP).
