

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ESTABLISHING THE NEW CLASSIFICATION OF UTILITIES MANAGER, AND SETTING ITS BASIC COMPENSATION RATES, AND AUTHORIZING CHANGES IN ALLOCATION OF BUDGETED POSITIONS.

WHEREAS, the City of Rialto desires to establish the classification of Utilities Manager; and

WHEREAS, the Utilities Manager shall be appointed "at-will" and exempt from classified services and serves at the pleasure of the City Council. This position will provide analysis and review of the activities and operations of the water/wastewater utilities within the Public Works Department and under a Public Private Partnership (P3); to coordinate review activities with other departments and outside agencies; and to perform a variety of duties relative to assigned areas of responsibility; and

WHEREAS, the City of Rialto desires to add the classification of Utilities Manager to its Classification Plan at a basic compensation rate at Range 6100 (\$7,626 - \$10,220 monthly) benefits for this classification will be tied to the Rialto Mid Management Association; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: To establish the classification of Utilities Manager. Essential functions and responsibilities are included in Exhibit A.

Section 2: To set the basic compensation rate as outlined in this Resolution.

Section 3: To amend the number of authorized budgeted positions for fiscal year 2016/2017.
