WHEREAS, the Authority departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the Executive Director; and

WHEREAS, the Executive Director may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Board.

NOW, THEREFORE, THE RIALTO HOUSING AUTHORITY BOARD DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Approved and increase appropriations of \$50,000 in Account No. 236-500-1793-2011 to pay LDM Associates to manage housing projects and \$300,000 from CalHome Program Income in Account No. 246-500-1751-2011 to fund the Home Sweet Home Program and Mortgage Assistance Program.
