## RESOLUTION NO.

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ACCEPTING THE CALRECYCLE TIRE DERIVED PRODUCT GRANT FUNDS FOR THE USE IN WITHIN LANDSCAPING THE CITY OF RIALTO, AND AMENDING THE FISCAL YEAR 2017-2018 BUDGET.

WHEREAS, the budget for fiscal year 2017-2018 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of
expense, with character of expense being defined as personnel services, services and
supplies, capital outlay, debt service and transfers, without the consent of the City
Administrator; and

WHEREAS, the City Administrator may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

WHEREAS, the City Council of the City of Rialto requires a five-year Capital Improvement Program (CIP), which is updated annually

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

**Section 1:** Approve an increase in estimated revenues in the amount of \$149,986 to the Grants Project Fund, Account Number 223-400-7302-7536-180203-06; and

**Section 2:** Authorize the appropriation of \$149,986 from Grants Project Fund, Account Number; 223-500-7302-3001-180203-06 for the landscaping projects at the Easton and Cedar Reservoirs, project expenditures.
