3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 RIALTO, CALIFORNIA, ACCEPTING THE CALRECYCLE TIRE
5 DERIVED PRODUCT GRANT FUNDS FOR THE USE IN
6 LANDSCAPING WITHIN THE CITY OF RIALTO, AND
7 AMENDING THE FISCAL YEAR 2017-2018 BUDGET.

8 WHEREAS, the budget for fiscal year 2017-2018 of the City of Rialto has been
9 adopted by this Council in its original form, and said budget will need to be amended at times
10 to fulfill the goals of the City; and

11 WHEREAS, the City departments may not exceed their appropriations by character of
12 expense, with character of expense being defined as personnel services, services and
13 supplies, capital outlay, debt service and transfers, without the consent of the City
14 Administrator; and

15 WHEREAS, the City Administrator may transfer appropriations, between departments
16 and within their respective funds, as long as those appropriations do not exceed their fund
17 total unless approved by Council.

18 WHEREAS, the City Council of the City of Rialto requires a five-year Capital
19 Improvement Program (CIP), which is updated annually

20 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
21 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

22 Section 1: Approve an increase in estimated revenues in the amount of \$149,986
23 to the Grants Project Fund, Account Number 223-400-7302-7536-180203-06; and

24 Section 2: Authorize the appropriation of \$149,986 from Grants Project Fund,
25 Account Number; 223-500-7302-3001-180203-06 for the landscaping projects at the Easton
26 and Cedar Reservoirs, project expenditures.
