14	approved by Council.

16	HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:
17	Section 1: Approve the decrease in designation in the amount of \$110,655 from General
18	Fund Reserved – Capital Project – Street Account No. 010-310-0714-0002 and appropriate \$110,655 in
19	General Fund – Capital Projects Transfers Account No. 010-500-0001-5030.
20	Section 2: Approve an appropriation in the General Fund Account No. 010-500-0001-5030
21	and increase estimated revenues in Capital Project Fund Account No. 300-500-8150-3001-150304-01 in
22	the amount of \$110,655 to facilitate transfer of funds from General Fund for the Frisbie Park Expansion
23	Project.
