3 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**  
4 **RIALTO, CALIFORNIA, AMENDING ITS 2017-2018 FISCAL**  
5 **BUDGET FOR THE FRISBIE PARK EXPANSION PROJECT**  
6 **DESIGN FOR \$110,655.**

7 **WHEREAS**, the budget for fiscal year 2017-2018 of the City of Rialto has been adopted by this  
8 Council in its original form, and said budget will need to be amended at times to fulfill the goals of the  
9 City; and

10 **WHEREAS**, the City departments may not exceed their appropriations by character of expense,  
11 with character of expense being defined as personnel services, services and supplies, capital outlay, debt  
12 service and transfers, without the consent of the City Administrator; and

13 **WHEREAS**, the City Administrator may transfer appropriations, between departments and  
14 within their respective funds, as long as those appropriations do not exceed their fund total unless  
15 approved by Council.

16 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES**  
17 **HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

18 **Section 1:** Approve the decrease in designation in the amount of \$110,655 from General  
19 Fund Reserved – Capital Project – Street Account No. 010-310-0714-0002 and appropriate \$110,655 in  
20 General Fund – Capital Projects Transfers Account No. 010-500-0001-5030.

21 **Section 2:** Approve an appropriation in the General Fund Account No. 010-500-0001-5030  
22 and increase estimated revenues in Capital Project Fund Account No. 300-500-8150-3001-150304-01 in  
23 the amount of \$110,655 to facilitate transfer of funds from General Fund for the Frisbie Park Expansion  
24 Project.
