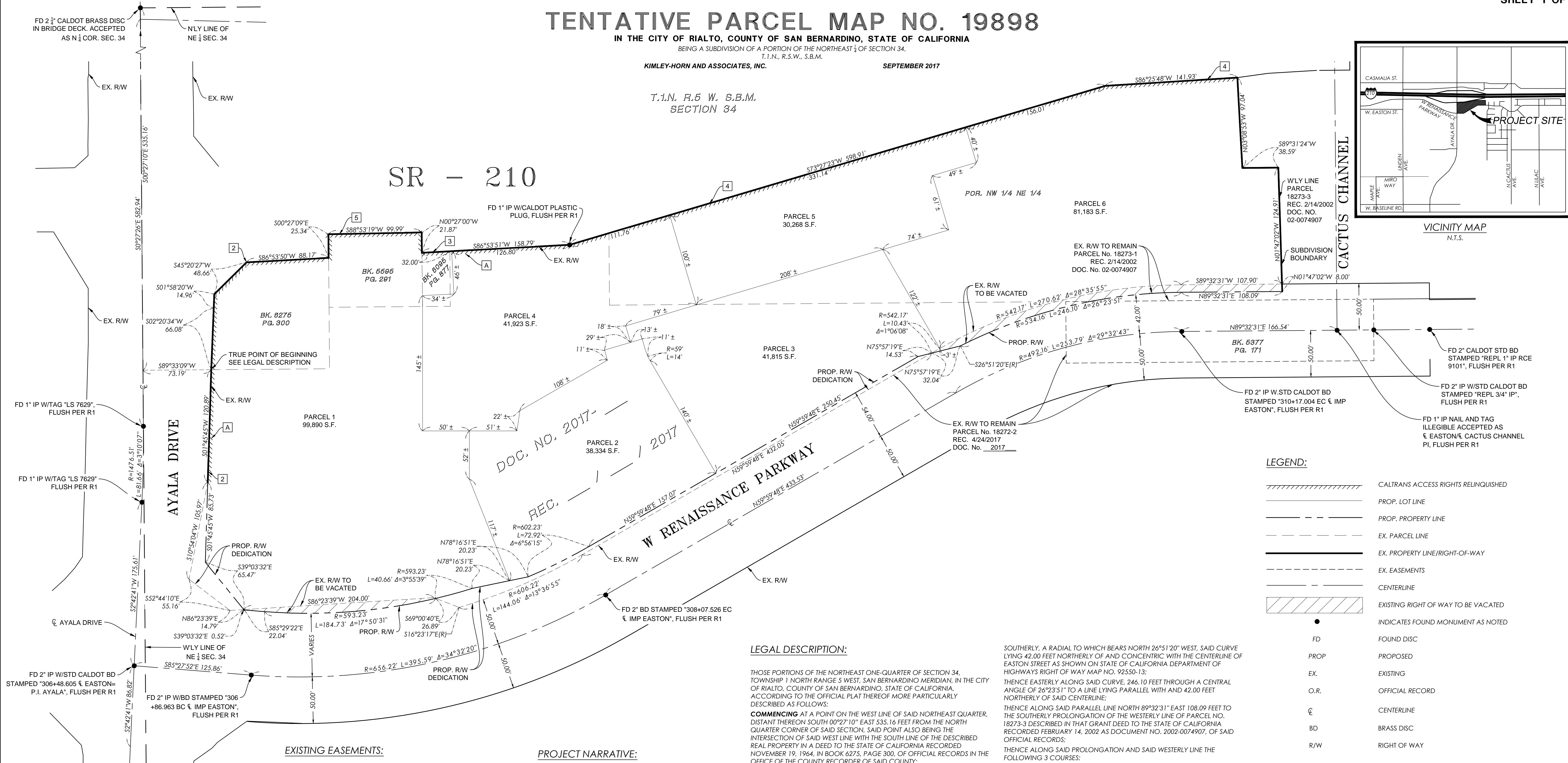

BASIS OF BEARINGS:

THE BASIS OF BEARINGS FOR THIS SURVEY IS THE CALIFORNIA COORDINATE SYSTEM 83, ZONE 5, NAD 83, EPOCH 2010.00, AS DETERMINED LOCALLY BY A LINE BETWEEN CONTINUOUS OPERATING REFERENCE STATIONS (CORS) "EWPP" AND (CORS) "GISA" BEING SOUTH 82°35'11" EAST.

LEGAL DESCRIPTION:

THOSE PORTIONS OF THE NORTHEAST ONE-QUARTER OF SECTION 34, TOWNSHIP 1 NORTH RANGE 5 WEST, SAN BERNARDINO MERIDIAN, IN THE CITY OF RIALTO, COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, ACCORDING TO THE OFFICIAL PLAT THEREOF MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT ON THE WEST LINE OF SAID NORTHEAST QUARTER, DISTANT THEREON SOUTH 00°27'10" EAST 535.16 FEET FROM THE NORTH QUARTER CORNER OF SAID SECTION, SAID POINT ALSO BEING THE INTERSECTION OF SAID WEST LINE WITH THE SOUTH LINE OF THE DESCRIBED REAL PROPERTY IN A DEED TO THE STATE OF CALIFORNIA RECORDED NOVEMBER 19, 1964, IN BOOK 6275, PAGE 300, OF OFFICIAL RECORDS IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY;

THENCE ALONG SAID SOUTH LINE NORTH 89°33'09" EAST, 73.19 FEET TO THE **TRUE POINT OF BEGINNING**;

THENCE LEAVING SAID SOUTH LINE ALONG THE EASTERLY AND NORTHERLY LINES OF PARCEL NO. 18272-2 DESCRIBED IN THAT GRANT DEED TO THE STATE OF CALIFORNIA RECORDED APRIL 24, 2017 AS DOCUMENT NO. 2017-016962, OF OFFICIAL RECORDS OF SAID COUNTY RECORDER'S OFFICE, THE FOLLOWING 4 COURSES:

- 1) SOUTH 01°45'45" WEST 120.89 FEET;
 - 2) THENCE SOUTH 10°54'04" WEST 105.97 FEET;

THENCE EASTERLY ALONG SAID CURVE, 184.73 FEET THROUGH A CENTRAL ANGLE OF 17°50'31" TO SAID NORTHERLY LINE;

THENCE ALONG SAID NORTHERLY LINE THE FOLLOWING 3 COURSES:

- 1) SOUTH 69°00'40" EAST 26.89 FEET TO THE BEGINNING OF A NON-TANGENT 606.22 FOOT RADIUS CURVE CONCAVE NORTHWESTERLY, A RADIAL TO WHICH BEARS SOUTH 16°23'17" EAST;

SOUTHERLY, A RADIAL TO WHICH BEARS NORTH 26°51'20" WEST, SAID CURVE LYING 42.00 FEET NORTHERLY OF AND CONCENTRIC WITH THE CENTERLINE OF EASTON STREET AS SHOWN ON STATE OF CALIFORNIA DEPARTMENT OF HIGHWAYS RIGHT OF WAY MAP NO. 92550-13;

THENCE EASTERLY ALONG SAID CURVE, 246.10 FEET THROUGH A CENTRAL ANGLE OF 26°23'51" TO A LINE LYING PARALLEL WITH AND 42.00 FEET NORTHERLY OF SAID CENTERLINE;

THENCE ALONG SAID PARALLEL LINE NORTH 89°32'31" EAST 108.09 FEET TO THE SOUTHERLY PROLONGATION OF THE WESTERLY LINE OF PARCEL NO. 18273-3 DESCRIBED IN THAT GRANT DEED TO THE STATE OF CALIFORNIA RECORDED FEBRUARY 14, 2002 AS DOCUMENT NO. 2002-0074907, OF SAID OFFICIAL RECORDS;

THENCE ALONG SAID PROLONGATION AND SAID WESTERLY LINE THE FOLLOWING 3 COURSES:

PROJECT NARRATIVE:

THE PROPOSED PROJECT IS A SUBDIVISION OF 1 EXISTING PARCEL INTO 6 PROPOSED PARCELS. IN ADDITION, THIS PROJECT REQUIRES VACATION OF PORTIONS OF RENAISSANCE PARKWAY ALONG WITH RIGHT OF WAY DEDICATIONS FOR RENAISSANCE PARKWAY TO EFFECT THE STREET RE-ALIGNMENT. NO OTHER PUBLIC EASEMENTS ARE CONTEMPLATED TO BE REQUIRED.

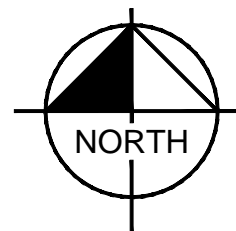
