N-1 NOTICE IS HEREBY GIVEN that sealed bids for the **Metrolink Parking Lot Expansion Project, City Project 170808**, will be received by the Office of the City Clerk of the City of Rialto, California, until 3:00 P.M. on **January 25, 2018**, at which time they will be opened and read aloud. The Engineer's estimate range is \$1,000,000 to \$1,200,000.

N-2 DESCRIPTION OF THE WORK: The Work generally consists of construction of a parking lot expansion at 178 W. Bonnie View Dr. including utility relocation and coordination; construction of asphalt concrete pavement, Portland cement concrete sidewalk, access ramps, curb and gutter and driveways; construction of underground storm drainage improvements; installation of underground electrical and parking lot lighting system; construction of irrigation system and landscaping improvements; traffic striping and signage improvements; and all appurtenant work.

The work shall be diligently prosecuted to completion before the expiration of: **90 working days**.

N-3 AWARD OF CONTRACT:

(a) The City reserves the right after opening bids to reject any or all bids, to waive any informality (non-responsiveness) in a bid, or to make award to the lowest responsive, responsible bidder, and reject all other bids, as it may best serve the interest of the City. If there are multiple and/or alternative Bid Schedules, Bidders are required to bid on all Bid Schedules.

(b) As a condition of award, the successful bidder will be required to submit payment and performance bonds and insurance.

(c) Bidders are advised that, as required by federal law, the City of Rialto is implementing Disadvantaged Business Enterprise requirements for this project. Bidders shall refer to the Special Provisions for the DBE requirements related to this contract. **The DBE Contract goal is 4.63%.**

N-4 BID SECURITY: each bid shall be accompanied by a certified or cashier's check or Bid Bond in the amount of 10 percent of the total bid price payable to the City of Rialto.

N-5 BIDS TO REMAIN OPEN: The Bidder shall guarantee the Total Bid Price for a period of 90 calendar days from the date of bid opening.

N-6 CONTRACTOR'S LICENSE CLASSIFICATION: The Contractor shall possess a valid Class A Contractor license at the time of submitting bids.

N-7 CALIFORNIA WAGE RATE REQUIREMENTS: The Contractor shall pay the general prevailing rate of per diem wages as determined by the Director of the Department of Industrial Relations of the State of California for the locality where the work is to be performed. A copy of said wage rates is available on-line at:

The Contractor and any subcontractors shall pay not less than said specified rates and shall post a copy of said wage rates at the project site.

N-8 FEDERAL WAGE RATES: The Federal minimum wage rates for this project as predetermined by the United States Secretary of Labor are included in the Contract. If there is any difference between the State or Federal wage rates, the Contractor and subcontractors shall pay not less than the higher of the two rates. The City will not accept lower State wage rates not specifically included in the Federal minimum wage determinations. This includes "helper" (or other classifications based on hours of experience) or any other classification not appearing in the Federal wage determinations. Where Federal wage determinations do not contain the State wage rate determination otherwise available for use by the Contractor and subcontractors, the Contractor and subcontractors shall pay not less than the Federal minimum wage rate, which most closely approximates the duties of the employees in question.

N-9 RETAINAGE FROM PAYMENTS: The Contractor may elect to receive 100 percent of payments due under the Contract Documents from time to time, without retention of any portion of the payment by the City, by depositing securities of equivalent value with the City in accordance with the provisions of Section 22300 of the Public Contract Code.

N-10 FEDERAL NON-DISCRIMINATION PROVISION: Bidders shall comply with the President's Executive Order No. 11246.

N-11 FEDERAL INTEREST EXCLUSION: Any contract or contracts awarded under this Notice Inviting Bids are expected to be funded in part by a grant from the United States Government. Neither the United States nor any of its departments, agencies, or employees is or will be a party to this Notice Inviting Bids or any resulting Agreement. This procurement will be subject to regulations contained in 40 CFR Part 33 and 35.

N-12 PUBLIC WORKS CONTRACTOR AND SUBCONTRACTOR REGISTRATION: Pursuant to California Labor Code Division 2, Part 7, Chapter 1, Article 2, a contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, or engage in the performance of any contract for public work with the City of Rialto, as defined in said chapter, unless currently registered with the California Department of Industrial Relations and qualified to perform public work pursuant to Labor Code § 1725.5 [with limited exceptions from this requirement for bid purposes only under Labor Code § 1771.1(a)]. It is not a violation of this section for an unregistered contractor to submit a bid that is authorized by § 7029.1 of the Business and Professions Code or by §§ 10164 or 20103.5 of the Public Contract Code, provided the contractor is registered to perform public work at the time the contract is awarded.

All Contractors and Subcontractors performing work on this project shall be required to furnish electronic certified payroll records directly to the Labor Commissioner (i.e., California Department of Industrial Relations - Division of Labor Standards Enforcement). The awarded Contractor shall post jobsite notices as prescribed by regulations.

All Bidders and their subcontractors (that are listed on – List of Proposed Subcontractors or Sub-Tier Contractors) shall provide an extract from the Public Works Contractor Registration web site with their submitted bid providing evidence of active registration with the Labor Commissioner.

N-13 APPRENTICESHIP PROGRAM: Attention is directed to §§ 1777.5, 1777.6 and 1777.7 of the California Labor Code and Title 8, California Administrative code, Section 200 et seq. to ensure compliance and complete understanding of the law regarding apprentices. In accordance with §§ 1777.5 and 1777.6 of the Labor Code, as amended, and the regulations of the California Apprenticeship Council, properly indentured apprentices may be employed in the prosecution of

the work. Attention is directed to §§ 1777.5 and 1777.6 of the Labor Code concerning the employment of apprentices by the Contractor or any subcontractor under him/her.

N-14 MANDATORY PRE-BID MEETING: Prospective bidders advised to attend the mandatory pre-bid meeting to acquaint potential bidders with the project and existing site conditions that may affect the work. The meeting will be held on **Tuesday, January 16, 2015, at 10:00 AM local time.** The meeting will be held at the project site located at 178 W. Bonnie View Dr., Rialto, CA. **The City will only consider bids submitted by those bidders who attend the Mandatory Pre-Bid Meeting. All other bids will be considered as non-responsive and subject to rejection.**

N-15 OBTAINING OR INSPECTING CONTRACT DOCUMENTS:

(a) Contract Documents may be inspected without charge at the City of Rialto Public Works Department, 335 W. Rialto Ave., Rialto, CA 92376.

(c) Obtaining Bid Documents and registration as a Bidder: If you are interested in submitting a bid, Bidders shall register directly at the Planetbids.com website. **Bidders must be registered with the Planetbids.com website to submit a Bid;** failure to register shall be cause to find a Bid non-responsive.

(d) Bidders shall obtain Bid Documents from the City of Rialto via the PlanetBids.com website. **The Bid Forms in the Bid Documents shall be used to submit a bid.**

(e) All questions about the meaning or intent of the Bid Documents are to be directed to the City Engineer. Questions shall be submitted electronically via the **Q&A tab** of the Project found at the **PlanetBids.com website** under the Bid Opportunities portal. Questions must be submitted electronically at least 5 working days prior to bid opening.

N-16 ADDRESS AND MARKING OF BIDS: The envelope enclosing the Bid shall be sealed and addressed to the City of Rialto, and shall be delivered or mailed to the **Office of the City Clerk, 290 W. Rialto Ave., Rialto, CA 92376.** The envelope shall be plainly marked in the upper left hand corner with the name and address of the Bidder and shall bear the words "Bid For.." followed by the title of the Project and the date and hour of opening Bids. The certified or cashier's check or Bid Bond shall be enclosed in the same envelope with the Bid.
