13	within their respective funds, as long as those appropriations do not exceed their fund total unless
14	approved by Council.
15	NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
16	HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:
17	Section 1: 1. Appropriate the following expenditures related to the Construction and
18	Credit Agreement with CapRock Partners LLC, as follows:

20	a. Storm Drain Facilities Development Impact Fee Fund Account No. 230-500-4720-300 increase in the amount of \$52,200.00 for storm drain improvements; and
21	b. Fair Share Impact Mitigation Impact Fee Fund Account No. 301-500-4312-3001 in the
22	amount of \$344,500.00 for street improvements on Riverside Avenue; and
