

RESOLUTION NO. ___

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, IMPLEMENTING CALIFORNIA ASSEMBLY BILL 1379, CODIFIED IN SECTION 4467 OF THE CALIFORNIA GOVERNMENT CODE, IMPOSING A STATE-MANDATED FOUR DOLLAR FEE ON ALL NEW APPLICATIONS AND RENEWALS OF LOCAL BUSINESS LICENSES.

WHEREAS, the Governor of the State of California approved Senate Bill No. 1186 ("SB 1186"), Disabilities Access, on September 19, 2012, which provided that from January 1, 2013 to December 31, 2018, any applicant for a local business license or any applicant for the renewal of a business license has to pay an additional one dollar (\$1) fee for that license to be collected by the city that issued the license; and

WHEREAS, on January 22, 2013, the City of Rialto approved a one dollar (\$1) fee to be implement from January 1, 2013 to December 31, 2018 as required by SB 1186; and

WHEREAS, the Governor signed California Assembly Bill 1379 ("AB 1379"), Certified Access Specialist Program: Funding, on October 11, 2017; and

WHEREAS, AB 1379 mandates that from January 1, 2018 to December 31, 2023, any new and renewal applicant of a local business license must pay an additional fee of four dollars (\$4) for that license to be collected by the city who issues the license; and

WHEREAS, the City desires to comply with AB 1379, codified in Section 4467 of the California Government Code by implementing a fee of four dollars (\$4) on all new applications and renewals of existing local business licenses for a term of five (5) years beginning on January 1, 2018 to December 31, 2023 pursuant to AB 1379.

NOW, THEREFORE, the City Council of the City of Rialto does hereby resolve, declare, determine and order as follows:

Section 1: The foregoing recitals are true and correct and are incorporated herein by reference.

1	Section 2: That the City Council hereby finds and declares, as required by the State of		
2	California, a fee of four dollars (\$4) will be imposed on all new applications and renewals of existing		
3	local business licenses for a term of five (5) years beginning on January 1, 2018 to December 31,		
4	2023.		
5	Section 3: That the City Council directs City staff to provide notice to local business		
6	owners and begin the collection of the four dollar (\$4) fee as required by AB 1379.		
7	Section 4. If any provision of this Resolution is held invalid, such invalidity shall not		
8	affect the remaining provisions of this Resolution, which shall remain in effect absent the provision		
9	held to be invalid, and to this end, the provisions of this Resolution are declared to be severable.		
10	Section 5: The City Clerk shall certify to the passage and adoption of this Resolution and		
11	enter it into the book of original Resolutions. This Resolution shall be effective immediately upon		
12	passage and adoption.
