**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
RIALTO, CALIFORNIA, AMENDING ITS 2017-2018 FISCAL
BUDGET AND APPROPRIATING FUNDS FOR THE NATIONAL
ENDOWMENT FOR THE ARTS LIVABILITY PROGRAM
GRANT**

WHEREAS, the budget for fiscal year 2017-2018 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Administrator; and

WHEREAS, the City Administrator may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

Section 1: Authorize an increase in estimated revenues in:

Account No. 248-400-8811-7560 in the amount of \$20,000;

Account No. 248-400-8811-9010 in the amount of \$20,000;

Section 2: Approve an appropriation in the National Endowment for the Arts Livability Program Grant Fund:

Account No. 248-500-8811-2011 in the amount of \$10,000;

Account No 248-500-8811-1001 in the amount of \$2,500;

Account No 248-500-8811-1010 in the amount of \$2,500;

Account No 248-500-8811-1020 in the amount of \$10,000;

Account No 248-500-8811-2021 in the amount of \$15,000

Section 3: Approve an appropriation in the General Fund Account No. 010-500-0001-5020 in the amount of \$20,000 for the Cities Match.
