A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ACCEPTING THE \$1,260,000 GRANT FROM SOUTHERN CALIFORNIA ASSOCIATED GOVERNMENTS REGIONAL COUNCIL AND THE CALIFORNIA TRANSPORTATION COMMISSION AS PART OF THE AUGMENTED 2017 ACTIVE TRANSPORTATION PROGRAM FOR THE CACTUS AVENUE MULTI-USE PATH PROJECT.

WHEREAS, the City of Rialto is eligible to receive State funding from the California Transportation Commission; and

WHEREAS, the measures proposed in the Road Repair and Accountability Act of 2017 (Senate Bill [SB] 1, Chapter 5, Statutes of 2017) created the Local Partnership Program; and

WHEREAS, forty million dollars (\$40,000,000) is to be allocated by the California Transportation Commission to local or regional transportation agencies that have sought and received voter approval of taxes or that have imposed fees, which taxes or fees are dedicated solely for transportation improvements; and

WHEREAS, the City of Rialto, if selected, will enter into an agreement with the State of California Transportation Commission to carry out the project;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Accepting the Augmented 2017 Active Transportation Program Grant through the Road Repair and Accountability Act of 2017, (Senate Bill (SB) 1) for the Cactus Trail Improvement Project, , and

Section 2: Authorize the City Administrator, or designee of the City of Rialto, as agent to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, and payment requests and so on, which may be necessary for the completion of the aforementioned project(s)

Section 3: Approve an increase in estimated revenues in the amount of \$1,260,000 to the SB1 Grants Project Fund, Account Number 203-400-7315-7536-170801-06 for the Cactus Avenue Multi-Use Path Project.

Section 4: Authorize the appropriation of \$1,260,000 in Grants Project Fund, Account Number 203-500-7315-3001-170801-05 for the Cactus Avenue Multi-Use Path Project.

Section 5: The City Clerk shall certify as to the adoption of this Resolution as of the date set forth below.
