A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, SETTING THE AMOUNT OF THE BUSINESS LICENSE TAX FOR WHOLESALE LIQUID FUEL STORAGE FACILITIES PURSUANT TO ORDINANCE NO. 1556 FOR THE 2018/2019 FISCAL YEAR

WHEREAS, on December 9, 2014, the Rialto City Council declared the results of the election held on November 4, 2014, in which Ordinance No. 1556 was approved by the voters of the City of Rialto; and

WHEREAS, Ordinance No. 1556 provides that any person engaged in the business of owning, operating, leasing, supplying or providing a wholesale liquid fuel storage facility shall pay an annual business license tax of up to One Dollar (\$1.00) per year for each One (1) cubic foot of liquid fuel storage capacity; and

WHEREAS, Section 6 of Ordinance No. 1556 provides that the City Council shall establish the amount of the tax annually by resolution each fiscal year in an amount not to exceed the maximum amount specified in the Ordinance; and

WHEREAS, on May 10, 2016, the City Council adopted Resolution No. 6951, which established certain policies for the implementation of the wholesale liquid fuel storage tax, including that the storage capacity of tanks which are empty for the entire applicable year will not be included in calculating the amount of the tax; and

WHEREAS, the City Council desires to establish the amount of the tax for Fiscal Year 2018/2019.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

Section 1: The foregoing recitals are true and correct and are incorporated herein by reference.
