Kosmont Update on Casmalia Site Outreach

As part of the Economic Development Services for the City of Rialto regarding the Casmalia Site, Kosmont Companies ("Kosmont") was tasked with outreach to RV Dealers / tenants. Kosmont reached out and gathered responses from various RV dealers and organizations that are active in California. (see attached list). Kosmont suggests the City continue this RV dealer outreach as part of ongoing communication and relationship building between the City and business community.

Kosmont had some insightful conversations with RV dealers and potential tenants and in many instances where merited, followed up with an email flyer of the Campalia Site. In addition, City may consider the following findings/questions from interested businesses:

- Coordinate site tours with interested RV Dealers for March/April.
- Thus far, RV Dealers seem too be more interested in leasing rather than purchasing the site.
- Discuss with RV Dealers the sale / lease price range for the Casmalia Site.
- What if the dealer only wants to lease a portion of the Site?
- Questions regarding freeway visibility and signage?

Here are a few of the relevant responses and comments:

- Giant RV We're opening new locations and our concern is what if we don't need the entire 13 acres?
 Would the City be open to a lease on a portion of the Site? Mostly interested in a lease situation.
- 2. Aistream Inland Empire We are actively looking for locations. There are concerns about freeway visibility and would need to see the Site. Besides airstream we also carry other brands, and would the City be open to an RV and Boat center, perhaps other recreational vehicles / equipment as well? Could the City be helpful on the permitting and development process?
- 3. CalRVDA We will reach out to a few of our members who are expanding. What is the price range for sale or lease?
- Code3 RV, We are expanding and are interested in new sites. What price range is the City thinking?
 We would consider a lease.
