At this meeting, the City Council will receive public comment on the draft One-Year Action Plan (2018-2019) and Substantial Amendment to the 2017-2018 Action Plan that will be submitted to the U.S. Department of Housing and Urban Development (HUD).

BACKGROUND

The Action Plan will appropriate CDBG, funds to specific programs and projects for the 2018-2019 fiscal year. The City anticipates receiving \$1,126,668 in federal community development funds for the 2018-2019 Program Year to implement programs and projects that benefit low- and moderate-income residents. In the event that the actual amount of CDBG funding received from HUD is higher or lower than anticipated, the City will adjust the funding amounts for each project/activity identified in the draft One-Year Action Plan proportionally and in compliance with regulatory requirements for funding allocations to certain types of CDBG projects/activities. The Substantial Amendment to the 2017-2018 Action Plan will eliminate two activities, the Section 108 Loan Repayment activity and the Lights at Frisbee and Bud Bender Park. The funds for these two projects plus unallocated funds will total \$644,434 which will be reprogrammed to new activities identified in the 2018-2019 Action Plan.
